Poljska zakonodaja glede gospodarjenja z odpadki

Polish legal regulations concerning waste management

POVZETEK

Trg gospodarjenja z odpadki na Poljskem se je v preteklih letih precej spremenil, predvsem zaradi naporov države, da ujame države t.i. zahodne Evrope. Prenos direktiv EU je pospešil stopnjo modernizacije obstoječih obratov in prisilil podjetja k nadaljnjam vlaganjem, zlasti pri zmanjševanju odlaganja odpadkov na odlagališčih. V skladu z direktivami Evropske unije je bila spremenjena hierarhija ravnjanja z odpadki, vse v cilju vzpostavitev dodatnega pritiska na pravila preprečevanja in zasnovno družbe "recikliranja" ter v tem okviru izvajanja vrednot: preprečevanje nastajanja odpadkov ter ponovno uporabo in recikliranje odpadkov.

Namen prispevka je predstaviti glavne zakonske predpise ravnjanja z odpadki na Poljskem, glede na zakonodajo, ki se nanaša na področje recikliranja. Najpomembnejši tok odpadkov na Poljskem predstavlja industrijske odpadke, zato je v članku prikazana kratka analiza zakonskih predpisov, povezanih s to skupino odpadkov, ki se osredotoča na odpadke iz industrije izkoriščanja mineralnih surovin.

Ključne besede: odpadki industrije za izkoriščanje mineralnih surovin, jalovišča, zakonodaja, gospodarjenje z odpadki.

ABSTRACT

The waste management market in Poland has undergone a significant change over the past years, largely as a result of the country trying to catch up with so called Western Europe. Transposition of EU directives has accelerated the pace of modernization of existing plants as well as forced the companies to engage in further investments, especially in the reduction of landfilled waste. In accordance with the European Union Directives, the hierarchy of waste management was modified, with the aim to put special pressure on the rule of prevention and the conception of 'recycling society', and within their frames on the activities implementing those values: the prevention of waste production, preparing for reuse and recycling.

The purpose of the paper is to present main polish legal regulations concerning waste management, with regard to law deeds describing issues of recycling. The most important waste stream in Poland comprises industrial wastes and therefore there was done a short analysis of legal regulations connected with this group of wastes, which is focused on wastes from extractive industry.
